## MINUTES OF A MEETING OF THE TARPORLEY PARISH COUNCIL HELD IN THE COMMUNITY CENTRE COMMITTEE ROOM ON Monday 12<sup>th</sup> JANUARY 2015

PRESENT Councillors: V Adshead, J Blackford, R Brierley, E Chapman, G Clough, G Lees, J Mills, K Parker (Chairman), D Press, J Russell, R Statham and A Wallace, CWaC Councillor E Moore-Dutton in attendance.

**1.** Open Forum: Notification of additional late planning applications 14/05288/FUL, 14/05257/FUL. Update by PCSO Adam Miscikas: 7 incidents, 2 arrests. Priorities for coming month – youth activity at public conveniences and parking on zig-zags.

Resident Ernest Boynes made plea for PC action to ensure best use of Royal British Legion land following demise of Tarporley Club. Asked for CWaC involvement to be requested and encouraged. Further input and advice given by resident Derek Gibbon advocating improved connectivity from High Street to Oathills and Primary School. CWaC Councillor is) to seeking a view on options.

Clerk will write and request copy of deed for consideration of PC options.

It was reported that the bench and dog faeces bin at the end of Burton Avenue had vanished. Faeces bags were being deposited on the grass. To be investigated.

CWaC Councillor expressed concern about findings of Parking Survey regarding time limited parking. Councillors advised they saw it as beneficial – but as ONE strand of improvement with the overriding message that more spaces are needed.

M George delivered a report on the progress of the Neighbourhood Plan. Numerically at step 3 of 9, but actually about 90% through the work. Thanks recorded to participants for thousands of hours input principally from the Steering Group, and to consultants Kirkwells and thanks for the grant support via CWaC and Locality. A number of detailed points were noted by Cllr Blackford as needing changing to enable the NP to be approved for going to consultation. A further informal meeting was needed to agree future points to be added into consultation.

- 2. Start of formal business, Welcome new Deputy Clerk David Carter; No apologies for absence.
- **3.** Councillor's declarations of interest and requests for dispensation under the Localism Act 2011 s33; to note the ongoing dispensations for Cllr Chapman to speak but not vote on Brook Farm development proposals, Cllr Russell to speak but not vote on Brook Farm development proposals, Cllr Lees to speak but not vote on Birch Heath Road development proposals and Cllr Mills to speak but not vote on Nantwich Road and High School development proposals.
- **4.** The minutes of the meetings of the  $8^{th}$  December 2014 and  $29^{th}$  December 2014 were approved and signed.
- **5.** Update on matters resolved at earlier meetings not on this Agenda: Clerk had contacted CWaC regarding minor error in Precept calculations which had been accepted.
- **6.** PLANNING: a) No public comments received on planning applications.

e) Monthly planning review group for next meeting to be Cllr's Russell, Statham and Parker.

- **7.** Major housing developments (over 4 dwellings): The application re houses at Rode St was going to appeal, Councillors to attended public meeting. Arderne Farm proposed development, no application lodged to date, outside NP Settlement Area, request from Bloor Homes for a further meeting to be declined but the reply to draw attention to the adequacy of the CWaC 5 year housing supply and the draft NP. Resolved to send Cllr Blackford's statement to Your Housing Group stating Council view over Affordable Housing.
- **8.** Neighbourhood Plan Steering Group: Received for approval the final proposed version of the Tarporley Neighbourhood Plan and resolved that the document be put forward for public consultation, subject to minor amendments. Changes discussed and agreed at this meeting to be forwarded to the Clerk for collation and forwarding to Kirkwells. It was noted that further issues may emerge and a meeting to detail any such minor amendments will be held and any such amendments could be proposed at the pubic consultation stage.
- **9.** Annual Footpaths Report: Received from Cllr Press and noted, the report to be filed with the minutes. Agreed recommendations and it was resolved to commit to an expenditure of £3100 on the recommended actions.
- **10.** RBL Club: Considered actions in relation to the potential closure of the club including consideration of the Community Right to Bid. Clerk will write and request copy of deed for consideration of PC options.
- **11.** Brook Farm Sports & Recreation Field: Working Group of Cllr's Blackford, Lees, Chapman & Wallace reported on progress. Currently awaiting proposal from the preferred consultants Groundwork Cheshire. Cllr Blackford noted the need for adequate long term management arrangements.
- 12. Village Square: Cllr Brierley provided update on progress, he will circulate costs to date to members. It was resolved to spend a further £1700 on consultation using Groundwork to undertake the public consultation.
- 13. Village Parking: The Community Centre manager had repaired and added to lines in car park for clarification, creating several new spaces. CWaC had agreed to work to those lines when enforcing. Ramp to the building is NOT within their controlled area. Costs for asphalt replacement and final line painting can be done estimated £4500. Council resolved to provide £1500. Noted that CWaC & the Community Centre to contribute £1500 each.
- Park Road. Cllr Clough progressing with CWaC the provision of additional yellow lines to prevent parking on the RHS outside hospital and Health Centre, and both sides after Health Centre to Primary School.Cllr Clough presented a plan which Council resolved to approve. CWaC to implement subject to the Council agreeing to pay.
- **14.** Mr D Carter has commenced employment as Deputy Clerk with the intention to progress to appointment as Clerk and RFO subject to satisfactory regular review. Clerk and Deputy to agree and pursue a training and handover programme.
- **15.** Display Boards: Cllr Press reported that Hinchliffes were open to using their electronic window display board to carry Council notices. Detail, format etc still to be reviewed and final Council Decision to be made. To avoid favouritism the Council would be prepared to provide info for display on any village display (Doctors, Pharmacy etc). Further information and consideration at next meeting.
- **16.** Brass Band: Given the difficulties being faced by the Tarporley Band it was resolved that the Council would make a booking with Bollin Brass for the 2015 Christmas Lights event. Also agreed that IF Tarporley Brass were available we may have both.
- 17. Quality Status: It was agreed that Clerk would complete application for Foundation Status for 2015 at no cost. Cllr's Parker & Clough to consider the implications, costs and benefits of other levels (Silver & Gold) with Clerk & Deputy Clerk to report back.
- **18.** Parish Polls Consultation: Clerk was instructed to complete consultation questionnaire in support of the proposed changes .

In accordance with Standing Orders it was resolved to extend the meeting to 10:00 to deal with the agenda

**19.** ACCOUNTS: a) The Councillor's expenditure and income statements were received and approved and it was noted that Cllr Blackford had inspected the accounts. It was noted that the budget for the year was £72,341 pro rata for 9 months £54,255 current actual approved expenditure for 9 months £64,473 bank balance £109,193 of which £11,776 is not reserved and income for 9 months was £99,789.
