MINUTES OF A MEETING OF THE TARPORLEY PARISH COUNCIL HELD IN THE COMMUNITY CENTRE COMMITTEE ROOM ON Monday 9th February 2015

PRESENT Councillors: V Adshead, J Blackford, R Brierley, E Chapman, J Mills, K Parker (Chairman), D Press, R Statham

- 1. Open Forum: Notification of additional late planning applications see 1g) .
 - a. Resident Sue Goldstone commented on the continued worsening of traffic and parking issues on Eaton Road outside the High School especially before 9:00 when busses and parents and students all arrive together and parking limits the street to one way at-a-time movement.
 - b. PC Ged Gigg commented that it would be beneficial to safety to pursue an extension of 2 cars length to the double yellow lines on Eaton Rd towards the High St. He would also make contact with parking enforcement to try to get them to spend more time policing bad street parking than seeking easy hits in the car parks. Contacts to be made with CWaC and school bus companies and report further at next meeting. JB commented that current PCSO is less often and less widely visible than previous PCSO. PC Gigg to investigate.
 - c. Resident Tom Kenny advised that Tarporley Twins Bohars would be visiting Tarporley Sat 2nd May to celebrate 30 years of twinning and invited Councillors to events on Saurday and Sunday 3rd. Chair KP to consider.
 - d. Tony Yeates & Linda Martin updated on the Community Centre Car Park improvements. Recycling bins to be removed (at a loss of income of £1000 pa), and resurfacing(£3k), relining (£2k), drop kerb (£1900) and ancillary costs of £500. PC has committed to pay for drop kerb, and advised TY to provide full costing and request for support. Closure planned 13=17 April. Costs for the new planned path to the North of the Rec could be £20k. TY looking at lower cost options. Again TY to provide costing and request for funding.
 - e. Peter Heberlet and Gethin Owens from Ground works delivered presentation to support their quote for consultancy relating to the Brook Rd Recreation Ground. KP clarified that initially we only needed sketch plans of several options for the purpose of discussion of options at a public meeting. PH to provide requote just up to initial sketch stage by 13/02. Agreed to hold public display in TCC Saturday 21st March.
 - f. Resident E Boynes requested that TCC actively engage with the Royal British Legion to pursue the best interests of Tarporley in their future plans for the land at the Clubhouse, Car Park, Allotments and Bowling Green
